The following points were discussed in the meeting of Institutional Research Ethics Committee, chaired by Dr. Amit Dixit (Registrar, Quantum University).

1. Welcome Address

Dr. Santosh Kumar Verma extended a warm welcome to all members, highlighting the importance of the Institutional Research Ethics Committee within the university.

2. Approval of Previous Minutes

The minutes of the previous meeting were reviewed and unanimously approved by all committee members.

3. Workshop on Ethics

External Experts, Dr. Vipin and Dr. Kshitij, advised organizing a workshop on research ethics for MBA and PG students. They emphasized the importance of adhering to paid plagiarism detection systems in the university.

4. Plagiarism Check for Synopsis

It was suggested to ensure plagiarism checks for all PG and PhD student synopses. The reports should be reviewed before approval.

5. CTRI Registration

All PG and PhD research work involving clinical trials should be uploaded on the Clinical Trial Repository of India (CTRI) to ensure authenticity. A CTRI registration number will be generated for official documentation.

6. Formation of Bioethics and Biohazards Committees

The committee discussed forming dedicated sub-committees on Bioethics, Biohazards, and Animal Ethics. It was suggested to include external experts, particularly from social welfare, in these committees.

7. Plagiarism Check on Shodhganga Portal

Another point raised was the need to upload all PG students' work on the Shodhganga portal after thorough plagiarism checks.

8. Consent for Data Collection

A crucial agenda item was the necessity of obtaining formal consent from institutions where students collect data for their research, ensuring compliance with ethical standards.

9. Advocacy for New Ideas and Research Authenticity

The committee urged its members to continue their efforts in advocating for innovative ideas and ensuring the authenticity of all research work conducted within the university.

10. Closing Remarks

The meeting concluded with expressions of gratitude to all present members for their valuable contributions and active participation.
